What is the overall deductible?	\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; For In-Network Providers \$6,500 Individual or \$13,000 Family; for Out-of-Network Providers \$8,000 Individual or \$16,000 Family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Primary Care Provider office visits and Wellness and preventive care are not subject to the deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. For some Prescription Drug tiers: \$1,000 Individual/\$2,000 Family. What is the out-of-pocket limit for this plan?	For In-Network providers: \$8,550 Individual/\$17,100 Family.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
